CCRSPA MINUTES - May 21, 2017

The group gathered at 11:00 AM at Schaefer's Canal House. Past President Kathy Mullen called the meeting to order at 11:15 AM. The Pledge of Allegiance was said.

Business Meeting

Introduction of Guests Deborah Chance from MRSPA and Georgia Renk from Mount Harmon Plantation were introduced. New Retirees introduced were Connie Davis, Bert Brown and Ron Hazel.

Deborah Chance reported that the state was in the process of selecting a new Executive Director. There were 124 applicants, with 24 meeting requirements. A selection will be made by July.

Georgia Renk represented Mount Harmon Planation. She explained it is a nonprofit organization. There is a need for volunteers who can act as docents, can add to school programs with many colonial activities, and can help with on day festivals. Over 1000 students visited this year. A Revolutionary War Re-enactment will be held in October 2018. There will be a Lotus Blossom Festival in August 5, 2017. It will be closed from October 31, 2017 through April 30, 2018. Mount Harmon has a website and is on Facebook.

The March 21, 2017 minutes were approved.

Treasurer's Report was presented.

COMMITTEE REPORTS

Legislative. Linda Elwood reported that our pensions are secure. SB 540 was opposed and went nowhere. HB 415 – essential generic drugs was passed. Waiting for governor to sign. HB 1 - Health Leave Family Act was passed giving 5 days of sick leave if more than 15 employees are employed. Governor has not signed yet. Call and ask governor to pass by Thursday. Call 844-284-6884, and give name and zip code. Generic Drug Act to prevent price gouging.

Membership. Sherry Lewis said we had one new member, Fred Barrett. We have 292 members with two more coming and eleven local members. Lorraine Newman is a new Emeritus Member.

Nominations. Cards were on the table for nominations for President, President elect, Secretary, and Nominations Chair.

Pre-retirement Benefits. Paul Humphrey reported that changes have been made in Mutual Funds. There is nothing to report on Health Care yet.

Communications. Have articles to Gretchen Ginder for the September Chalkboard by August 7.

Social. Call or email Diana Lohr if coming to the luncheons. Payment can be made at the door.

Programs. For our May meeting there is no formal program due to recognitions. The first luncheon in the fall will be October 3 due to the length of the Ireland trip. Mary will contact Mary Ann Jung to perform at the March meeting.

Wellness Day. Will be held at Elkton High School on Friday, May 25, 2017 from 8:00 a.m. until 2:00 p.m. Everyone is invited. We will have a booth to provide information and a hold a raffle. We are targeting those planning to retire within the next two years.

Scholarship. Marie Madron and Libby McCullough gave background on the scholarship program. Twenty-nine scholarships have been given starting in 1987. The first scholarships were worth \$200.00. The two scholarships presented today are for \$1000.00 each. Thank you to all who make direct contributions and who buy raffles. The trips organized by Fred Metzger also add to the scholarship fund. The two recipients for this year are Courtney Spangler and Liam Rawley.

Members were recognized for their volunteer work this year. At the MRSPA annual meeting, we received a commendation for our volunteer work for this year.

Food pantry drawing for the Can-Can Program went to Trinity United Methodist Church in Chesapeake City.

Business meeting closed at 12:00.
