### **Business Meeting**

The May 23, 2017 minutes were approved.

Treasurer's Report was presented. Tony Mattern will be the new treasurer. Forms for reimbursement can be found on the CCRSPA website. An executive board member must sign reimbursement forms before submitting to Tony. Send any web links to Tony to be used on Facebook. He needs someone to proofread anything he puts on our site. He would like to have someone to work with him to learn the treasurer's position.

We will give Paul Montgomery a gift card to recognize his many years of service to the Association.

Members are still needed to fill officers' positions and committees.

#### **COMMITTEE REPORTS**

Fred Metzger reported that 34 people went on the trip to Ireland. It was a great trip. Another trip will be planned for 2019. Ann Hill presented a check for \$2605.16 for our scholarship program.

**Community Outreach.** Some supplies were donated to Generation Station. Books collected may not be given to the library. There haven't been as many requests for coats as in the past. Schools need clothes, such as pants, shirts, and shoes. School nurses have been contacted. We received a thank you note from Cecilton Elementary.

**Legislation.** Legislative training meeting set for November.

**Preretirement.** There will be a preretirement meeting on November 5, 2017. MRSPA is our voice for pensions at the state level.

**Communications.** Have articles to Gretchen Ginder for the December Chalkboard by October 15, 2017. **Social.** Call or email Diana Lohr if you are coming to the luncheons. Payment can be made at the door. March luncheon meeting place has changed to Bomba's on Route 40. It was suggested that we purchase shirts with CCPSPA logo to wear when representing the association. More information will be provided at the December meeting.

**Benefits.** Audits reported finding that bus drivers were paid more than was budgeted. Jobs were performed without bids going out. Advisory Committee has said the retired teachers are no longer part of the meeting. We can have a representative but that person is not allowed to speak. ### **Benefits Advisory Meeting**

Delta Dental and Aetna – everything okay.

CCPS will be issuing Requests for Proposals (RFPs) for the PPO medical plan, prescription drug plan, and the vision plan. Mae will do as much as possible to prevent provider disruption. (Care First, Aetna, and United Healthcare are the big players in the medical insurance market.)

PRESCRIPTION DRUG PLAN – End of three-year contract. Most implementation problems were with Catamaran; however, some were related to Care First and Aetna not providing Catamaran with accurate data related to member prescription utilization. There have been very few issues over the past two years, but if you do have problems you can contact Liz Miller in the Benefits Office. She will help you resolve the issue and may be able to provide for a 30-day fill of the medicine while you work through the authorization process. If CCPS changes prescription drug providers, there may be some prescription tiers change.

Vision: Eye Med – The RFP will be issued with no recommended change to the plan outline.

No plan change for retirees with Medicare. Pre 65 retirees will no longer be with Aetna. Highmark or CareFirst are covering most of the state exchange plans. Aetna has submitted two renewal rates for Medicare Advantage plan.

If the state and federal exchanges were to collapse (too late for that to happen in FY18) CCPS would provide retirees with a group-sponsored plan. Retirees who elect coverage through their spouse can still receive the Health Reimbursement Account funds from the Board however the HRA funds cannot be used to pay the spouse's premiums, only non-reimbursable medical expenses per the IRS. If the retiree elects medical coverage through a new employer they forfeit any rights to the CCPS HRA funds.

# **Community Outreach – Kids Fund**

Jan Yuninger has reported helping 4 schools with school supplies from nurse request earlier in the school year. A thank you note was read from Cecil Elementary school nurse, Evelyn carry thanking us for children's underwear for boy size XS to L.

Foods like chips, apples, etc. are sent on Friday for food to have for the weekend to some children in Perryville Middle and Northeast Middle.

Paula Cobb has delivered note books, note book paper, pens, pencils, poster board paint, glue, and book bags to the Generation Station, an Out of School Program for students in grades six through nine. They provide a safe environment between the hours of 2:45 and 5:45 pm when most parents are still working. Each program day includes both homework and instructional time to help students reach their academic potential. A healthy snack is provided. Students are picked up at school at dismissal time and transportation home is provided at the end of the program day. It is located near Bohemia Manor Middle School and High School.

Books donated will be given to Union Hospital.
