# CCRSPA MINUTES – February 26, 2019

The group gathered at 11:00 AM at Minker Hall. President Anne Humphrey called the meeting to order at 11:15 AM.

The Pledge of Allegiance was said.

First time visitors were introduced.

#### Minutes were approved.

**Treasurer's Report** – Anne stated we have money. The report will be in the newsletter and if anyone has questions to please see Tony Mattern. We are on track with the budget. The treasurer's report was approved.

#### **COMMITTEE REPORTS**

**Benefits** - Paul Humphrey stated that new retirees would only have Aetna Medicare Advantage to choose for their healthcare provider. If you already have Care First, you will be able to keep that as your provider.

**Community Outreach** - Paula Cobb had a folder on each table with forms for members to record their volunteer hours. Coats, hats, gloves, scarves and underwear were purchased for students at Holly Hall Elementary. Nominations for the Senior Citizen Hall of Fame are due to Paula by April 8. Your nominee does not need to be a CCRSPA member. Gretchen Ginder was inducted into the Hall of Fame last year.

**Constitution** - Every two years our constitution needs to be looked at for any changes or additions that may need to be made. A meeting to look at the constitution will take place this summer. If you are interested in participating, please notify Kathy Mullen or Anne Humphrey.

**Consumer Education** - Tony Mattern reported that the information was on Facebook and the web. If you need information about AARP tax preparation, Tony can provide you with a phone number. The CCRSPA reimbursement voucher form is available on the web. The form requires one signature along with the signature of the individual submitting the form.

**Legislation** - Linda Ellwood presented information about legislative committee meetings held. Our pensions are in good shape. We're at 74% for full funding. Governor Hogan and MRSPA are protecting our pensions.

**Membership** - Sherry Lewis said membership is the same. Please consider receiving your Chalkboard via email. Contact Gretchen Ginder, Shirley Montgomery or Sherry Lewis if you want to change from receiving your Chalkboard by mail to receiving an email copy. Folding, stamping and labeling the Chalkboard takes about two hours for three individuals. Those of you that receive your Chalkboard by email are greatly appreciated. A reminder that if you bring a retiree from CCPS to a meeting, you'll get free raffle tickets. We want our membership to grow.

Scholarship - Any Cecil County Public High School graduate that is entering his/her junior or senior year of college and is majoring in education, is eligible to apply for a CCRSPA Memorial Scholarship. Charlene Metzger said the Deans of Education at various Maryland, Delaware, New Jersey and Pennsylvania Colleges, Cecil County Library branches, CCPS employees, and the Cecil Whig have been notified.

**Social** - Diana Lohr and Marie Madron would like to hear from you if you have a suggestion for a location that can accommodate 90 people for our CCRSPA meetings. We may need to raise the price of our luncheon depending on the menu. Diana thanked Marie for going to MacGregors to meet with Cindy, the catering manager.

**Travel** - Fred Metzger said there are spaces still available for the Canyonlands National Parks trip in September. Check out the website for more information or contact Fred.

**Program** - Mary McCleary thanked everyone that contributed to the raffle table and to everyone that purchased tickets. Mary Ann Jung provided the entertainment as Grace O'Malley, the Pirate Queen of Ireland. Our May meeting will be a busy affair. Mary is hoping Dr. Lawson, Superintendent of CCPS, will attend, scholarships will be awarded, volunteers will be recognized and the CCPS Teacher-of-the Year may attend.

#### **Additional Information**

- John Weaver, assistant principal at Thompson Estates, made a short presentation about the mentor program at his school. They have a need for mentors for the children. If interested, you would need to commit to ½ to 1 hour a week to meet with a child. Contact information was left with Anne.
- The MRSPA annual meeting is scheduled for May 8 at the Comfort Inn in Bowie, MD. Our organization is entitled to eleven delegates. It is an opportunity to hear about what is happening at the state level. Three scholarships will be awarded at the meeting. # SCAM ALERTS

In the March-April issue of *CONSUMER CONNECTION*, a list of Scams was explained and included suggestions for dealing with these Scams. We have included the kinds of scams discussed. For more information check out this publication of the MRSPA Consumer Education Committee on the CCRSPA website.

**IRS Scams**: Scammers are sending phony letters that appear to be from the IRS, demanding payment for back taxes.

Suspended Benefits or SSN Scam: A caller claims to be from the Social Security Administration (SSA) with news that your SSN or benefits have been suspended, because your number has been linked to criminal transactions involving drugs or money laundering.

Overpayment Scam: If you're selling an item that gets listed for saleonline, a scammer who poses as a buyer, contacts you. He agrees to buy your item and sends a fake check for more than the sale price. He asks you to wire the overpayment to him or to someone else.

Used Car Scam: Scammers advertise a used car for sale at an incredible deal. The scammer will claim the need to sell the car quickly, due to a divorce settlement or an upcoming move out-of-state. The scammer will pressure you to buy the car sight unseen and may ask you to pay with gift cards such as iTunes. Once you send payment, you will never hear from the scammer again.

#### More good scam-prevention tips from the Maryland Attorney General's office:

Puppy Scams: Scammers advertise puppies for sale and claim to be out-of-state. You agree to buy a puppy and the "seller" agrees to ship the puppy to you. Once you send payment, the scammer will ask for money to cover unexpected expenses such as insurance for shipping. Scammers will also advertise free puppies to a good home, but require you to pay for vet fees, shipping and insurance. You send money and the scammer will ask for additional money to cover unexpected fees. In either case, you never receive a puppy.

Extortion Scam: Thieves are using email to threaten victims into paying a ransom to prevent certain information from being circulated online. Scammers claim that they have hacked into your webcams, smart TVs or other smart device connected to the internet and have embarrassing

videos or photos of you or a family member. They threaten to release these videos or photos to your email contacts unless you pay them.

Never pay any money whether through wire transfer, online payment application, gift card, or Bitcoin, to any person or group that claims to have embarrassing videos, audio tapes, or photos of you or your family. Delete extortion emails and never click on any links in them.

Medicare Card Scam: Scammers pretend to be Medicare representatives, who ask to verify your information over the telephone. In another scam, a scammer offers a plastic Medicare card for a fee- even though the real Medicare cards are paper and there are no legitimate plastic cards. Medicare doesn't ask for personal information by telephone or charge a fee for Medicare cards.

Don't be fooled by scammers trying to get information from you!
