CCRSPA MINUTES - September 21, 2019

The group gathered at 11 AM at Schaffer's Restaurant. President Anne Humphrey called the meeting to order at 11:16. Eighty members attended this luncheon meeting.

Everyone participated in the Pledge of Allegiance.

First time attendees and guests were introduced.

The minutes from the May 21, 2019 meeting were approved.

COMMITTEE REPORTS:

Treasurer's Report - Tony Mattern reported that we have \$9006.51 in checking and \$11,179.90 in a CD for a total of \$20,186.41. If anyone purchases items for the organization, talk to Tony first, as he will not be reimbursing anyone for sales tax. Voucher forms for reimbursement are available on line.

Benefits - Paul Humphrey stated that active teachers have a concierge package in their wellness program. Retired teachers do not have this access but he will ask about it.

Community Outreach - Paula Cobb reported that the Maryland Senior Citizen Hall of Fame would be honoring MRSPA members for their volunteer service on October 24 in Glen Burnie. Sheryl Taylor will be honored for her volunteer service with PAWS as well as other organizations. If you are interested in attending, Paula will need your check by October 4. Paula has received requests for supplies from 20 schools. Please bring mittens, scarves, and jackets for children to our December meeting. She suggested purchasing children's' underwear and sweatpants when they're on sale to donate to the schools.

Constitution - Kathy Mullen stated that there is only one recommended change to our bylaws. All were in agreement to change the name "Coats for Kids" to "Kids' Fund".

Legislation - Linda Elwood shared that our Legislative priorities pamphlets have been updated for better readability with the #1 concern of pension protection on the far left since people read from left to right. January 8 is the opening of the General Assembly. The pamphlets will be delivered to delegates and senators on January 14. Upcoming issues include guns, crime, and funding. Lobby day is March 3, 2020, and all members are encouraged to attend. Wanda Twigg has been appointed to the Governor's Commission to lower insurance costs. The next legislative workshop on Wednesday, November 13, will be held at the Miller Office Building in Annapolis.

Membership - Anne Humphrey reported that our membership is 290-295. We are gaining members through enrollment but losing members due to death. Our goal is 315 members. Please encourage retirees to join. Their first luncheon will be free. The more members we have the more legislators will listen. All members are invited to a membership hour/cocktail hour on the patio at The Wellwood from 5 - 7 PM on Tuesday, October 8. The association will provide fruit and cheese trays in addition to sodas and iced tea. It will be a pay as you go bar. This event will enable those members who aren't able to attend luncheons the opportunity to participate. Shirley Montgomery will send out an email blast about this.

Nominations - We are in need of a nominating chair and a president to replace Anne Humphrey. Anne is in the fourth year of a two-year term and is resigning to take a state position. She encouraged members to consider joining with a friend to be copresidents of the organization.

She feels it isn't a difficult job because the many committee chairs do a good job of completing their work. There are 4 luncheon meetings a year and 4 executive board meetings that she leads. We also need a photographer to take photos for posting and for the newspaper or for award recognition. Anne is willing to do this if someone will volunteer for the President position.

Publications - Gretchen Ginder reported that she needs newsletter information for the next newsletter by November 5. 120 people are still receiving a hard copy of the newsletter. Gretchen expressed her appreciation to everyone who has been willing to give up his or her hard copy and read the newsletter online.

Scholarships - Charlene Metzger reported that MRSPA is offering four \$250.00 classroom grants to teachers across the state. Any active teacher who completes an application will be considered. Anne Humphrey announced that Cecil County would like to do the same thing on a smaller scale and give out three \$100.00 classroom grants to Cecil County teachers. Information will be available in early October and teachers must apply by November 1. The Cecil County winners will be announced in December and the teachers must use the money before the end of the school year.

Social - Diana Lohr reported that we are going back to the Rising Sun Banquet Hall in December. Thank you to Marie Madron for making this possible by arranging with the new owners for the hall rental fee to be waived for CCRSPA. We are hoping the February meeting will be held at the CC School of Technology.

Travel - Fred Metzger announced that 10 people are going on the Grand Canyon trip, which leaves this Saturday, September 14. The results of the survey, which was distributed at our last meeting regarding recommendations for a day trip, resulted in St. Michaels being selected as the destination. The runner up was Cape May, New Jersey. The St. Michaels day trip will be spring 2020

Additional Information:

Consumer Education - Tony Mattern is interested in getting a Car Fit initiative in Cecil County. This program ensures that people "fit" in their cars properly for maximum comfort and safety.

Charlene Metzger thanked everyone for their food donations. The food donations support the Agape program in CC schools. Charlene's committee meets weekly to pack bags for delivery to 12 elementary schools. Their school counselor identifies students who participate due to food insecurity. Approximately 250 students take home a food bag on Fridays to help them through the weekend.

Anne Humphrey adjourned the meeting at 11:59. Paul Humphrey gave the blessing for our luncheon.

There have been sad times, but am blessed with good health and the freedom to spend more time with the ones I love, to do things I want to do or need to do, (like travel to visit/help my daughter and her family, now in CA, spoil grandsons, take road trips and eat out with friends) Retirement gave me the freedom to just be able to do many activities or go somewhere at the drop of a hat. I have many great memories of my time teaching, which others who have retired still do share.

Community Service

Thank you for giving towards the Kid's Fund like you do. We could not do this sort of thing without your help. Janet Yuninger and Paula Cobb Sheldon bought everything from underwear, socks, pants, shoes, leggings, sweatpants, tee shirts, brushes, combs, hair ties, snacks and water to donate from our CCRSPA Community Outreach program to 20 different schools in the county including elementary, middle, and high schools for our nurses to use when taking care of the kids that come to their office. We tried to help with their "wish list" and our donations very much appreciated by all we came in contact with at the different schools.

AGAPE PROGRAM

We will continue to collect food items for Agape. Our organization serves approximately 250 children each week in 12 elementary schools in Cecil County. They are: Thomson Estates, Holly Hall, Gilpin Manor, Bainbridge, Perryville, North East, Conowingo, Elk Neck, Charlestown, Chesapeake City, Leeds, and Cecil Manor.

We provide a bag of food for the weekend to each child identified by the guidance counselors. A typical bag contains a can of pasta with meat, 2 soups, 2 fruits (applesauce, etc.), 2 snacks (goldfish crackers, cheese crackers, etc.), and 2 breakfast items. Our volunteers deliver these bags to the schools.

Please remember that children as young as 4 carry these bags home on Fridays. We cannot send regular size cereal boxes, large canned items, or large bags of snacks. All packages are opened and individual bags/boxes of items are sent home.

Items we need include: Canned beef and pasta (Beefaroni, spaghetti & meatballs, etc.) Single-serve cereal Granola bars

Individual fruit servings (applesauce, mandarin oranges, etc.) Individual snack bags (Goldfish, pretzels, etc. Ramen noodles Pop tarts Fruit snacks



You may need to cover your outdoor unit if you have central air conditioning. If you use window air conditioners, remove them, or cover them to prevent air leaks.
