CCRSPA MINUTES - February 8, 2021

A ZOOM executive board meeting was held on Monday, February 8, 2021. The meeting began at 1:00.

Because of the current pandemic situation, there will not be a CCRSPA meeting in May. We are tentatively planning to have a meeting in September. The final decision will be made in August as to if, where, and when the luncheon meeting will take place.

Community Outreach chairpersons, Paula Cobb Sheldon and Kay DiStefano, have been purchasing items requested by some of the school nurses.

The Scholarship Committee wants to award Memorial Scholarships this year. Betsy Van Culin moved and Paul Humphrey seconded that three \$1000.00 scholarships be awarded.

Linda Elwood provided some information about the virtual meetings held by the state Legislative Committee. The State Legislature session started on January 13. Fourteen hundred bills have been introduced. There was much talk about long-term care. Care in assisted living facilities is a concern because all of the help is not certified. Some Memory Care units do not have trained personnel. Linda will be sharing more information in the Chalkboard.

Linda Elwood talked about the Dolly Parton Imagination Library. Currently 500 children from newborn to age 5 from the towns of Chesapeake City, Conowingo, Elkton, North East, Perryville, Port Deposit, and Rising Sun receive a book a month. It costs approximately \$1000.00 a month to send the books to the children. Linda moved and it was seconded that our organization donate \$500.00 to the Dolly Parton Imagination Library in Cecil County. Information will be forthcoming about how members can donate individually to the organization.

Another ZOOM meeting will be held in May. The meeting adjourned at 2:05.

Dolly Parton Imagination Library of Cecil County currently provides books to children ranging in age form 0-5. This program has been extremely successful and we have been able to register approximately 500 children in seven towns. Each child receives an age appropriate book every month and by age 5 children enrolled from birth, will have a library of 60 books that have been read and reread to them. As educators, we are aware of the need to expose children during these early years to literature and a vocabulary rich environment, which will help prepare them for kindergarten.

MRSPA's Legislative Committee

The committee met virtually during the fall. We reviewed the Legislative Priorities for 2021and made revisions to this brochure. Prior to the opening of the Legislative Session, which began on January 13th, an introductory letter was sent to Delegates and Senators with a copy of our priorities.

Since the opening of the session the Legislative committee has been meeting virtually bimonthly. Each member receives a print out of the bills that pertain to our pension and issues that effect seniors. These bills are reviewed and discussed and then we decide whether the association will support or oppose the bill. Letters are often sent to the Legislators stating our position and giving recommendations for additions or deletions if needed.

Numerous bills are reviewed and discussed, so I encourage those of you who are interested to go to mrspa.org, click on Legislation and then scroll down and click on Legislation Updates. You will see bills we reviewed and the position we took. If you are interested in finding out more information on the bill, click on the House bill or Senate bill in blue at the top. Then once the bill comes up you will see a thumbtack and the blue bill number under it. When you click on that the entire bill as written can be seen.

A Legislative Workshop was also held January 26, 2021. Sixty-four members took part virtually. Dean Kenderdine, Executive Director Maryland State Retirement and Pension System, gave an outstanding report and I am happy to report our pensions are secure. Tammy Bresnahan from AARP also gave a very informative presentation. She reviewed many concerns AARP has about seniors and the care they receive. One concern that she stressed was that in Assisted Living Facilities many of their employees are not certified and there are few regulations in place. This does not apply in most Nursing Homes and in home care organizations.

Ms. Bresnahan also warned us against Third Party Electric Suppliers. Apparently their Standard Offer Service and Transmission fee is an unregulated part of their bill and is often higher than normal, costing some citizens about \$700 more a year. She said these companies target seniors.
